ORDER GRANTING PRELIMINARY APPROVAL OF PROPOSED SETTLEMENT WITH THE BOSCH DEFENDANTS, FOR PROVISIONAL CERTIFICATION OF THE BOSCH DIRECT PURCHASER SETTLEMENT CLASS, AND FOR AUTHORIZATION TO DISSEMINATE NOTICE TO THE DIRECT PURCHASER SETTLEMENT CLASSES

Upon consideration of the Direct Purchaser Plaintiff's Motion for Preliminary Approval of Proposed Settlement with Robert Bosch GmbH and Robert Bosch LLC (together, "Bosch" or the "Bosch Defendants"), for Provisional Certification of the Bosch Settlement Class, and for Authorization to Disseminate Notice to the Direct Purchaser Settlement Classes (the "Motion"), and supporting memorandum (the "Notice Memorandum"), it is hereby ORDERED as follows:

- 1. The Motion is hereby **GRANTED**.
- 2. Terms used in this Order that are defined in the Bosch Settlement Agreement (the "Bosch Settlement Agreement") are, unless otherwise defined herein, used as defined in the Settlement Agreement.

Preliminary Approval of Bosch Settlement Agreement

- 3. The terms of the Bosch Settlement Agreement are hereby preliminarily approved as being fair, reasonable, and adequate to the Settlement Class, subject to a fairness hearing. In preliminarily approving the Settlement Agreement, the Court makes the following findings:
  - a. The proposed class representative and Co-Lead Settlement Class Counsel have adequately represented the Settlement Class;
  - b. The Bosch Settlement Agreement was entered into at arm's length by experienced counsel and is sufficiently within the range of reasonableness that notice of the Bosch Settlement Agreement should be given to members of the proposed Bosch Settlement Class;
  - c. The relief provided for the Bosch Settlement Class is adequate; and
  - d. The Settlement Agreement treats members of the Bosch Settlement Class equitably relative to each other.

### **Class Certification**

- 4. Pursuant to Rule 23 of the Federal Rules of Civil Procedure and in light of the proposed settlement, the Court hereby finds that the prerequisites for a class action have been met, and provisionally certifies the following class for settlement purposes (the "Bosch Settlement Class"):
  - All individuals and entities who purchased Starters in the United States directly from Defendants (or their subsidiaries or affiliates) from January 1, 2000 through March 12, 2018. Excluded from the Settlement Class are Defendants, their present and former parent companies, subsidiaries and affiliates, federal governmental entities and instrumentalities of the federal government, and states and their subdivisions, agencies and instrumentalities.
- 5. For purposes of the Proposed Settlement Class definition, the following entities are Defendants: Robert Bosch GmbH; Robert Bosch LLC; Hitachi Automotive Systems, Ltd.; Hitachi Automotive Systems Americas, Inc.; Hitachi, Ltd.; Denso Corporation; Denso International

America, Inc.; Mitsuba Corporation; American Mitsuba Corporation; Mitsubishi Electric Corporation; and Mitsubishi Electric Automotive America, Inc.

6. The Court finds that provisional certification of the Bosch Settlement Class is warranted in light of the Settlement Agreement because: (a) the Bosch Settlement Class is so numerous that joinder is impracticable; (b) the Direct Purchaser Plaintiff Class Representative's claims present common issues and are typical of the Bosch Settlement Class; (c) the Direct Purchaser Plaintiff Class Representative and Co-Lead Settlement Class Counsel (identified below) will fairly and adequately represent the Bosch Settlement Class; and (d) common issues predominate over any individual issues affecting the members of the Bosch Settlement Class. The Court further finds that the Direct Purchaser Plaintiff Class Representative's interests are aligned with the interests of all other members of the Bosch Settlement Class. The Court also finds that settlement of this action on a class basis is superior to other means of resolving the matter.

## Appointment of Class Representative and Co-Lead Settlement Class Counsel

- 7. The Court hereby appoints Plaintiff Tiffin Motor Homes, Inc. to serve as Class Representative for the Bosch Settlement Class.
- 8. The Court hereby appoints the law firms of Freed Kanner London & Millen LLC; Kohn, Swift & Graf, P.C.; Preti, Flaherty, Beliveau & Pachios LLP; and Spector Roseman & Kodroff, P.C. to serve as Co-Lead Settlement Class Counsel for the Bosch Settlement Class, having determined that the requirements of Rule 23(g) are fully satisfied by these appointments.

#### Notice to Potential Settlement Class Members

9. On March 12, 2018, Plaintiff reached a proposed settlement with Defendants Mitsubishi Electric Corporation, Mitsubishi Electric US Holdings, Inc., and Mitsubishi Electric Automotive America, Inc. (collectively, "Mitsubishi Electric") for \$6,754,285.00. Following

notice to the Mitsubishi Electric Settlement Class and a hearing on October 3, 2019, the Court granted final approval to the Mitsubishi Electric settlement on October 15, 2019. (2:13-cv-01101, ECF No. 129).

- 10. On May 14, 2018, Plaintiff reached a proposed settlement with Defendants Hitachi Automotive Systems, Ltd. ("HIAMS") for HIAMS, Hitachi, Ltd. and Hitachi Automotive Systems Americas, Inc. (collectively "HIAMS Defendants") for \$1,368,462.00. Following notice to the HIAMS Settlement Class and a hearing on October 3, 2019, the Court granted final approval to the HIAMS settlement on October 15, 2019. (2:13-cv-01101, ECF No. 130).
- 11. On August 14, 2018, Plaintiff reached a proposed settlement with Defendants MITSUBA Corporation and American Mitsuba Corporation (collectively, "MITSUBA") for \$2,642,257.00. Following notice to the MITSUBA Settlement Class and a hearing on October 3, 2019, the Court granted final approval to the MITSUBA settlement on October 15, 2019. (2:13-cv-01101, ECF No. 132).
- 12. On February 4, 2019, Plaintiff reached a proposed settlement with Defendants DENSO Corporation, DENSO International America, Inc., DENSO Korea Corporation (f/k/a separately as DENSO International Korea Corporation and DENSO Korea Automotive Corporation), DENSO Automotive Deutschland GmbH, DENSO Products and Services Americas, Inc. (f/k/a DENSO Sales California, Inc.), ASMO Co., Ltd., ASMO North America, LLC, ASMO Greenville of North Carolina, Inc. and ASMO Manufacturing, Inc. (collectively, "DENSO" or the "DENSO Defendants") for \$100,000.00. Following notice to the DENSO Settlement Class and a hearing on October 3, 2019, the Court granted final approval to the DENSO settlement on October 15, 2019. (2:13-cv-01101, ECF No. 131).

- 13. The Settlement Classes shall receive notice in accordance with the terms of this Order.
- 14. The Court approves the form and content of: (a) the Notice of Proposed Settlement of Direct Purchaser Class Action with the Bosch Defendants and Hearing on Settlement Approval and Related Matters, and Claim Form (the "Notice"), attached as Exhibit 2 to the Notice Memorandum; (b) the Summary Notice of Proposed Settlement of Direct Purchaser Class Action with the Bosch Defendants and Hearing on Settlement Approval and Related Matters (the "Summary Notice"), attached as Exhibit 3 to the Notice Memorandum; and (c) the Informational Press Release (the "Press Release"), attached as Exhibit 4 to the Notice Memorandum.
- 15. The Court finds that the mailing of the Notice and publication of the Summary Notice and Press Release in the manner set forth herein constitutes the best notice that is practicable under the circumstances, is valid, due and sufficient notice to all persons entitled thereto and complies fully with the requirements of Federal Rule of Civil Procedure 23 and the due process requirements of the Constitution of the United States.
- 16. On or before August 14, 2020, the Notice, in substantially the same form as Exhibit 2 to the Notice Memorandum, shall be mailed by first class mail, postage prepaid, to all potential members of the Settlement Classes identified by Defendants. The Notice shall also be provided to all persons who request it in response to the Summary Notice or Press Release. In addition, a copy of the Notice shall be posted on the Internet at <a href="https://www.autopartsantitrustlitigation.com">www.autopartsantitrustlitigation.com</a>, the website dedicated to this litigation.
- 17. On or before August 24, 2020, Co-Lead Settlement Class Counsel shall cause the Summary Notice, in substantially the same form as Exhibit 3 to the Notice Memorandum, to be published in one edition of *Automotive News*. Additionally, an online banner notice will appear

over a 21-day period on <a href="www.AutoNews.com">www.AutoNews.com</a>, the digital version of *Automotive News*. To supplement the notice program further, the Press Release, in substantially the same form as Exhibit 4 to the Notice Memorandum, will be issued nationwide via PR Newswire's "Auto Wire," which targets auto industry trade publications.

- 18. On or before September 14, 2020, Co-Lead Settlement Class Counsel shall file with the Court their motion or motions for: final approval of the proposed settlement with the Bosch Defendants; an award of attorneys' fees and expenses from the settlement proceeds; approval of a proposed plan of distribution of the settlement proceeds from the settlements with Bosch, Mitsubishi Electric, HIAMS, MITSUBA and DENSO (the five settlement funds are collectively referred to as the "Starters Settlement Fund"); and an incentive payment to the Class Representative to be paid from the Starters Settlement Fund.
- 19. All requests for exclusion from the Bosch Settlement Class must be in writing, postmarked no later than October 5, 2020, and must otherwise comply with the requirements set forth in the Notice.
- 20. Any objection by any member of the Bosch Settlement Class to the proposed settlement with Bosch, or to the request for attorneys' fees and expenses, must be in writing, must be filed with the Clerk of Court and postmarked no later than October 5, 2020, and must otherwise comply with the instructions set forth in the Notice.
- 21. Any objection by any member of the Bosch, Mitsubishi Electric, HIAMS, MITSUBA and DENSO Settlement Classes to the proposed plan of distribution of the settlement proceeds from the settlements or to the request for an incentive payment to the class representative, to be paid from the Starters Settlement Fund, must be in writing, must be filed with the Clerk of

Court and postmarked no later than October 5, 2020, and must otherwise comply with the instructions set forth in the Notice.

- 22. At least ten (10) days before the date fixed by this Court for the Fairness Hearing, Co-Lead Settlement Class Counsel shall file with the Court affidavits or declarations of the person under whose general direction the mailing and posting of the Notice, and publication of the Summary Notice and Press Release, were made, showing that mailing, posting and publication were made in accordance with this Order.
- The Court will hold a Fairness Hearing on November 5, 2020, at 2:00 p.m., at the 23. Theodore Levin U.S. Courthouse, 231 West Lafayette Blvd., Detroit, MI, 48226, Courtroom 817 (or such other courtroom as may be assigned for the hearing), to determine whether to approve: (1) the proposed Bosch settlement; (2) the proposed plan of distribution of the Starters Settlement Fund; (3) Co-Lead Settlement Class Counsel's request for an award of attorneys' fees and litigation costs and expenses from the Bosch settlement proceeds; and (4) the request for an incentive payment to the Class Representative, to be paid from the Starters Settlement Fund. Any Settlement Class member who follows the procedure set forth in the Notice may appear and be heard at this hearing. If the Court believes that it is appropriate, the hearing may be conducted remotely by telephone or other electronic means. If the Court determines to hold the hearing remotely, Settlement Class Counsel shall post that information on the website devoted to the direct purchaser litigation and provide any class member that has informed the Court that it intends to participate the information required to remotely participate. The Fairness Hearing may be rescheduled, adjourned or continued, and the courtroom assigned for the hearing may be changed, without further notice to the Settlement Classes.

24. Any Settlement Class member who wishes to participate in the distribution of the settlement funds must submit a Claim Form in accordance with the instructions therein. postmarked on or before November 21, 2020.

#### Other Provisions

- 25. In the event that the Bosch Settlement Agreement is terminated in accordance with its provisions, the Settlement Agreement and all proceedings had in connection therewith shall be null and void, except insofar as expressly provided to the contrary in the Settlement Agreement, and without prejudice to the status quo and rights of Plaintiff, the Bosch Defendants, and the members of the Bosch Settlement Class.
- 26. The Court's provisional certification of the Bosch Settlement Class as provided herein is without prejudice to, or waiver of, the rights of any Defendant to contest certification of any other class proposed in these coordinated actions. The Court's findings in this Order shall have no effect on the Court's ruling on any motion to certify any class in these actions or on the Court's rulings concerning any Defendant's motion, and no party may cite or refer to the Court's approval of the Bosch Settlement Class as persuasive or binding authority with respect to any motion to certify any such class or any Defendant's motion.
- 27. The Court approves the escrow account referenced in the Bosch Settlement Agreement as a qualified settlement fund ("QSF") pursuant to Internal Revenue Code Section 468B and the Treasury Regulations promulgated thereunder and retains continuing jurisdiction as to any issue that may arise in connection with the formation or administration of the QSF. Co-Lead Settlement Class Counsel are authorized to use funds from the QSF in accordance with the Bosch Settlement Agreement, including to pay costs of notice, taxes, tax expenses, and settlement administration costs.

28. The Direct Purchaser Class litigation against the Bosch Defendants is stayed except to the extent necessary to effectuate the Settlement Agreement.
